

Explain your relationship or affiliation to the person or organization.	I have previously represented the named defendant in other matters. I had been privately retained and have withdrawn my appearance and/or been replaced by successor private counsel. All other previous matters have been closed.
How do your official actions or decision matter to the person or organization?	I have supervisory and ultimate decision making authority relative to prosecutorial decisions of all criminal state matters in this District handled by the District Attorney's Office.


AFFIDAVIT OF DISTRICT ATTORNEY MARK G. MASTROIANNI
