These personal relations now work for the following companies: IBM, KPMG and Google. I have not heard back from my former colleague who works at Google. The former colleague who now works at IBM (and just started there within the past few weeks) sent my resume on to other colleagues from my time at American Management Systems whom I did not include in our initial conversation. These colleagues work at KPMG and Deloitte. My resume was forwarded to at least one recruiter at KPMG, although I'm not certain if it was by the former colleague I contacted or the former colleague who was contacted on my behalf. American Management Systems was acquired by CGI shortly after I stopped working there. I am an employee at ITD, and I handle a variety of IT contracts.
