

Please describe the particular matter.  I was made aware by a third party about a job opportunity as the Chief Medical Officer (CMO) of Fallon Health. Fallon Health has invited me to engage in interviews, and these discussions are voluntary on both sides. Fallon Health has SCO and PACE programs, and will be part of three out of the seventeen MassHealth ACOs launching on March 1, 2018 with whom MassHealth will be contracting to provide services to MassHealth members. Up until the present time, Fallon Health has also served as one of five Medicaid MCOs with whom MassHealth has contracted to provide coverage to MassHealth members.	
Your required participation in the particular matter:  E.g., approval, disapproval, decision, recommendation, rendering advice, investigation, other.	Please describe the task you are required to perform with respect to the particular matter.  I served as the CMO of MassHealth up until January 27, 2018, when I stepped down from that role and moved into a part-time consulting role with MassHealth. In my previous role as MassHealth CMO, I provided clinical leadership and help set clinical policy. Up until November 2016, I was involved in providing clinical leadership to the MassHealth ACO quality advisory workgroup which started laying down the foundation for the MassHealth quality measure slate, but I moved off of that workgroup long before the March 1, 2018 launch of the MassHealth ACO initiative and long before the ACO quality slate was finalized. Moreover, to the extent that any work I performed on the quality advisory workgroup had an impact on the future ACOs, that impact would apply across the board to all ACOs. Finally, I was never involved in the procurement of the actual managed care entities (MCEs) or ACOs; nor was I ever involved in contract negotiations with the MCEs or ACOs.  In my current role as a part-time consultant, my focus is primarily limited to assisting MassHealth with identifying and achieving cost savings initiatives for MassHealth's fee for service and PCC plan. These internal cost savings initiatives are not related to Fallon Health.  If I am offered the full-time CMO role at Fallon Health, I would give up my part-time consultant role at MassHealth.
