Re: Disclosure by State Employee of Financial Interest in a State Contract

To whom it may concern,

Attached please find my disclosure form as required by MGL c. 268A, § 7b. After consultation with your legal team, I understand that I am required to file this disclosure. I am currently employed full time at the Department of Youth Services. I have been asked to provide training services, in an area of my expertise, to the Department of Public Health, for a total of 12 hours in April 2019, as a 'key employee' of the Bijoux Consulting Group, LLC.

Specifically, the Department of Public Health has a contract with JJR Consulting to support their efforts to bring racial equity and diversity into the organization. One of their identified needs is training for their managers. JJR Consulting, through Jenna Roberts, has reached out to Bijoux Consulting Group, through Christian Bijoux, to provide that training. Mr. Bijoux specifically requested that I assist in this training as a 'key employee' due to my expertise in the subject matter and history of training on this material. We will provide two day-long trainings in April 2019 for DPH managers.

JJR Consulting only provided a final contact to Bijoux Consulting Group last week, even though we are set to deliver the trainings beginning on April 24, 2019. Therefore, I must apologize for any delay in providing this Disclosure. I also appreciate the support of Attorney Michael McDonald who pointed out some administrative error in my prior filing. 
