Particular matter E.g., a judicial or other proceeding, application, submission, request for a ruling or other determination, contract, claim, controversy, charge, accusation, arrest, decision, determination, or finding.	<p>Attorney Nick Scobbo, of Ferriter, Scobbo and Rodophele PC, currently has the following matters pending before the Department/EFSB:</p> <p>Attorney Scobbo has filed an appearance and a petition to intervene on behalf of NextEra Energy Resources in the open dockets (DPU 17-170 to 120) concerning long-term contracts for renewable energy filed by electric distribution companies for DPU approval pursuant to the Energy Diversity Act (St. 2016, c. 188, §12).</p> <p>Attorney Scobbo represents Channel Fish Company in connection with a proceeding before the Energy Facilities Siting Board ("EFSB") concerning a proposal by Eversource Energy to construct, operate, and maintain, among other things, a new substation on the East Eagle Street parcel in East Boston. The EFSB approved the proposal, with conditions, on November 30th. One of those conditions being that the EFSB directed Eversource to enter into discussions with the City of Boston regarding the possible relocation of the new substation and to provide an update to the EFSB on the status of such discussions before commencement of construction on the City parcel, and within six months of the Board's decision.</p>
