Other general legislation may come before the Senate that would codify the same policy objective.

Explain your relationship or affiliation to the person or organization.	My wife owns and operates a legal practice, the Law Offices of Alison Silber, which is a small business and received a loan pursuant to the federal paycheck protection program.
