

The activity promotes the interest of the Commonwealth by: (1) helping to enhance understandings of the political realities of governing a democracy in the Middle East and to learn more about Israel's culture, diversity, history, competencies, and challenges; (2) providing insight into how diverse stakeholders within a small geographic area manage and resolve competing interests and how the governments can work hand in glove with religious, cultural, and business leaders to serve their constituents; (3) enhancing ability to build relationships with key business sectors in which MA has a strong interest and in which Israeli companies have a strong presence in MA (e.g., cybersecurity, defense, technology, water, pharmaceutical, life sciences). Because Massachusetts is a top destination for Israeli entrepreneurs and innovators
