Dear District Attorney Tucker:

I am delighted to invite you to the New England Law | Boston 2023 Law Day Banquet, where Massachusetts Supreme Judicial Court Associate Justice David A. Lowy will be our esteemed guest. We are deeply honored that Justice Lowy has graciously agreed to speak at our Law Day Banquet this year and look forward to welcoming him.

The Law Day Banquet will take place on Friday, March 31, 2023, beginning at 6 p.m., at the Boston Marriott Copley Place, 110 Huntington Avenue, Boston. I would be honored if you would join us as a guest of the law school at our head table.

Justice Lowy was appointed to the Supreme Judicial Court by Governor Charles D. Baker. He earned a BA, cum laude, Phi Beta Kappa, from the University of Massachusetts Amherst in 1983, and graduated magna cum laude from Boston University School of Law in 1987. Following law school, Justice Lowy became an associate in the litigation department of Goodwin, Procter & Hoar (1987-1988 and 1989-1990), leaving for a year to work as a law clerk to Judge Edward F. Harrington in the United States District Court. He was also an assistant district attorney in Essex and Suffolk counties (1992-1997) and served as Deputy Legal Counsel to Governor William F. Weld (1992-1995).

Justice Lowy was first appointed to the bench in 1997 as a District Court judge. In 2001, Governor Paul Cellucci appointed him to the Superior Court bench. Justice Lowy served on the Supreme Judicial Court Advisory Committee on Massachusetts Evidence Law as an editor; that committee's work resulted in publication of the Massachusetts Guide to Evidence in 2008. Justice Lowy's teaching positions include adjunct professorships at New England Law (1991-present) and Boston University School of Law (2006-present), where he teaches courses in evidence.

New England Law has been fortunate to have hosted many distinguished speakers at our past events, including Chief Justice of the United States John G. Roberts, Jr.; Justices Ruth Bader Ginsburg, Antonin Scalia, Anthony M. Kennedy, Clarence Thomas, Sandra Day O'Connor, and Harry Blackmun; Massachusetts Supreme Judicial Court Chief Justices Margaret H. Marshall, Roderick L. Ireland, and Ralph D. Gants; Governor Charles D. Baker; Mayor Martin J. Walsh; Chief United Nations Weapons Inspector Dr. Hans Blix; Lieutenant Governor Karyn E. Polito; Congressman Joseph P. Kennedy III, and United States Court of Appeals, Third Circuit Judge Thomas M. Hardiman.
