After signing a Non-Disclosure Agreement, the name of the Company was revealed. I had heard of the Company, but didn't know much about it, and had no previous interactions with the Company in my current or previous roles at Massport. I informed the Search Firm that I was happy in my present job and not interested in pursuing the opportunity. In early 2023 the Search Firm contacted me again, asking me to consider a conversation with the Company to learn more. I agreed and had several exploratory conversations with the Company to learn about their industry, the organization, and potential employment opportunities.
	During subsequent meetings with Massport staff, I learned that Massport may have potential business with the company.
	Upon learning this information, I informed the Search Firm that I could not continue with the process unless I filed a disclosure with my appointing authority. After discussing the situation with the Search Firm and the Company, we agreed that I would file this disclosure to continue exploratory conversations about potential employment opportunities.
