I would like to be able to hire her for 4.5 hours per week effective February 25, 2025 through February 24, 2026.

Dr. Salicioni has been employed continuously by the Department of Veterinary and Animal Sciences since 2003, first in Dr. Joseph Jerry's lab (2003-2005) and then in my lab since 2005. Dr. Salicioni is an integral part of the lab, and she is named specifically in my two NIH RO1 grants: Sperm Ca2+ signaling and energy pathways in basic science and ART (PI: Pablo Visconti) RO1HD 038082-17A1 and Comparative studies on the regulation of metabolism during sperm capacitation (Multi PI: Pablo Visconti, Lonny Levin, Jochen Buck) RO1 HD088571-06. Specifically, our lab's scope of research is mainly focused on the understanding of molecular mechanisms conducive to making the male gamete fertilization-component, knowledge that would be very useful in the search for better in vitro fertilization methods as well as for finding male contraceptive targets. Dr. Salicioni is a highly skilled and independent investigator; she holds both a MS and a PhD in Biochemistry and possesses expertise in a wide variety of lab techniques in molecular endocrinology and cell biology -cell culture, in vitro fertilization, molecular cloning, computer assisted sperm motility assays using mouse, horse and human sperm. This set of skills makes her one of few scientists in the world uniquely suited for both performing and supervising experimental work in my lab. Furthermore, she is also proficient in discovery-driven techniques such as proteomics and yeast-two-hybrid assays, and in biochemistry- related methodologies required for drug discovery and protein characterization.

In the last five years, Dr. Salicioni held a 51 % dedication to my laboratory. In the last year she decreased her dedication to from 51 % to 20 %. Recently, Dr Salicioni has been appointed at the Interdepartmental graduate program IDGP administration office and she dedicates the 100% of her time to this appointment. This nepotism disclosure document pertains to the 4.5 hours per week dedicated to my laboratory as additional compensation, amounting up to 12% (\$9,037.42) of her current base salary. These hours will be in addition to her full-time role as the IDPG Graduate Program Business Manager. Her responsibilities as the IDPG Business Manager will take priority over her duties in the Visconti Laboratory. Because her dedication was decreased, direct experimental work with mouse sperm will not be pursued. Specifically, as part of her 4.5 hour per week dedication, Dr. Salicioni will train students and postdoc in my lab in several laboratory methodologies including kinase, sperm capacitation, and other biochemical assays. In addition, Dr. Salicioni will oversee the human sperm donor program in our lab. She is a named person for this purpose in my grants. She will also oversee issues regarding Animal protocols and contacts with IACUC.

Dr. Salicioni is also a Faculty Member in both the ABBS (Departmental) and MCB (Interdepartmental) Graduate Programs. With Category G in the ABBS granted by CNS College, she can teach graduate level courses, and can serve as member, or chair, of Master's and Doctoral Committees. Dr. Salicioni's scholarly knowledge and her extensive experience as a highly skilled researcher is evidenced through her contributions to her field of expertise by 54 publications, with an H-index of 29 and an average of 200 citations per year

(https://scholar.google.com/citations?user=uBHgFw4AAAAJ&hl=en). In addition, Dr. Salicioni is an established respected scientist nationally and internationally as demonstrated by her serving as an ad hoc Reviewer of seven international Scientific Journals. You state Dr. Salicioni is a highly skilled and independent investigator, holds both a MS and a PhD in Biochemistry, and possesses expertise in a wide variety of lab techniques that make her one of a very few scientists in the world who is uniquely suited for both performing and supervising experimental work in your lab. You further state that Dr. Salicioni will train students and postdocs in several laboratory methodologies, including kinase, sperm capacitation, and other biochemical assays, in your lab. Additionally, you indicate that Dr. Salicioni will oversee both the human sperm donor program and issues regarding Animal protocols and contacts with IACUC. Your request is supported by Lisa M. Minter, Professor and Department Head of Veterinary and Animal Sciences, and Michael Fox, Dean of the College of Natural Sciences.

Massachusetts General Laws, Chapter 268A, Section 6, in part, prohibits a state employee from employing immediate family members and from compensating them for services rendered except when I "make a written determination that the interest is not so substantial as to be deemed likely to affect the integrity of the services which the Commonwealth may expect from [...you], in which case it shall not be a violation for [...you] to participate in the particular matter." (M.G.L., Chapter 268A, Section 6.)

I determine that any personal interest you may have in this appointment is not so substantial as to be deemed likely to affect the integrity of your services to the Commonwealth and the Department of Veterinary and Animal Sciences.

This determination, which will allow you to re-appoint your spouse and utilize her services through February 24, 2026, must be reviewed and re-evaluated prior to any further appointment. If you wish to retain Dr. Salicioni on your research projects beyond February 24, 2026, please submit your request to the Chancellor of the Amherst campus to make such a review and re-evaluation by January 2, 2026. Dr. Salicioni's work must be performed within the procedures of Section 31.3 of the PSU-A Collective Bargaining Agreement.

The statute requires you to advise the Ethics Commission of the nature and circumstances of the particular matter and make full disclosure of the financial interest. As directed by statute, I am sending a copy of this written determination letter, along with your memorandum and disclosure form, to the State Ethics Commission for filing.
